FIRST AMENDMENT TO THE CARLTON HEIGHTS SECTIONS 5 AND 6 DECLARATION OF COVENANTS AND RESTRICTIONS

This First Amendment to the Carlton Heights Sections 5 and 6 Declaration of Covenants and Restrictions is executed as an amendment to that certain Carlton Heights Sections 5 and 6 Declaration of Covenants and Restrictions as filed with the Recorder of Hamilton County on or about December 14, 2016, as Instrument Number 2016-066107. This First Amendment is as follows:

Article 8, OWNERSHIP, USE, AND ENJOYMENT OF COMMONS is hereby amended to add the following paragraph to the end of such Article:

All "Commons" and "Common Areas" shall be maintained and repaired by the Association. Also, all areas designated on the Plat as "L.M.A.E.", Landscape Maintenance and Access Easement shall be maintained and repaired by the Association. In order for the Association to maintain and repair all such areas, each homeowner who has an L.M.A.E. designation on their Lot grants the Association and its agents, employees, vendors and contractors unfettered and unlimited access to the L.M.A.E. area for the purpose of maintaining and repairing the landscaping and any other improvements existing in the L.M.A.E.

All other terms and conditions of the Carlton Heights Sections 5 and 6 Declaration of Covenants and Restrictions as originally filed with the Recorder of Hamilton County shall remain in full force and effect without amendment.
